The largest single borrower represents approximately 6% of the portfolio. The top 10 borrowers that are assets of the Fund are: \$836,182, \$799,379, \$715,868, \$483,553, \$376,049, \$361,145, \$342,602, \$339,731, \$287,632 and \$280,024. The amount of loans that have been approved, but funds yet to be advanced is \$nil. Interest has been capitalised on nil loans totalling \$0m. The Fund may invest in derivatives for the purpose of managing interest rate risk. Derivatives will not be used for speculative purpose or to leverage the Fund. The amount of non-loans which are assets of the fund are approximately \$2.0 million. This is held as cash.
